Welcome to the new WIWG Education and Training Newsletter! With this newsletter we will celebrate the accomplishments of our members and offer information to help members progress in their Education and Training. This month's topic is the Yeager Award. This seemed appropriate for this Fall edition since General Yeager made world history twice in the Fall of the year; once on Oct. 14, 1947, when he became the first man to fly faster than the speed of sound and again when he flew twice the speed of sound in level flight on Dec. 12, 1953.

Adult Civil Air Patrol members earn the award upon successful completion of the Yeager test and are authorized to wear the Yeager Award ribbon. Members who earned the Spaatz Award as a cadet may be credited with completing the Yeager test and are authorized to wear the Yeager Award ribbon.



Why earn the Yeager Award? Aerospace Education is one of our three main missions. It is not only for cadets; it is for ALL members. There is an internal component (CAP members) and an external component (outreach). Earning the Yeager Award demonstrates a member's commitment to our AE mission. It helps prepare senior members to support both internal and external AE activities.

The Yeager Test is a self-paced test which can be done open book or closed book if you want to give yourself a challenge. For instructions on how to take the Yeager exam, NC Wing created a handy reference: How to take the Yeager Award Exam.

Yeager Award credit appears automatically in a member's eService record when it is passed. No other approval or paperwork is required. For this reason, your ETO or unit Commander may not realize you have completed it unless they happen to look for it. Let them know so they can recognize your achievement. Yeager Award certificates are printed by the squadron using the Certificates module in eServices. (eServices menu – Administration – CAP Certificates) Units are encouraged to present the certificate and ribbon to members at a meeting or award ceremony. The Yeager Award Ribbon can be purchased through Vanguard. Check with your unit to see if they supply ribbons or if members purchase their own.

The Yeager Award is a requirement of Level II in the Education and Training Program.

I hope that this encourages all senior members to complete the Yeager Test and that the next edition will be filled with members' names celebrating this accomplishment!
